

# The All-Party Parliamentary University Group



Dear Colleague,

The Higher Education and Research Bill is about to finish its passage through the House of Lords, with Third Reading taking place on Tuesday 4 April. There have been a number of amendments to the Bill in the Lords and so it will need to return to the Commons for approval. To note it is expected that this won't take place until the Commons returns from Recess on Tuesday 18 April but we will update you as soon as the date is confirmed.

The last couple of months have been busy for the sector with the Bill coming into the final stages, but despite this the group has continued its good work - work which is supported so well by all our members. For those of you that may have missed some of our recent outputs I've listed a few below that you may like to read or share with colleagues:

I'm also happy to share that today the group has published its second issue paper, "The Higher Education Sector and Brexit", this time hearing from three political parties on three important issues – student recruitment, staff recruitment and research - for higher education following the Prime Minister's triggering of Article 50 on Wednesday. The paper was written by myself, Alison Thewliss, Scottish National Party MP for Glasgow Central, and Flick Drummond, Conservative MP for Portsmouth South. I hope that our parliamentary members will use this as a short briefing in upcoming debates and discussions as it covers some of the important issues that will be of concern to our universities throughout the negotiation period.

Our next meeting is taking place on Wednesday 10 May and will look at degree apprenticeships and future skills, this will be following a visit, open to all parliamentary members of the group, to London South Bank University to discuss their degree apprenticeships programme first hand. I do hope that many of you will be able to join us.

# **Forthcoming Business**

# **Higher Education and Research Bill**

The Bill concludes its Lords stages with Third Reading rescheduled for Tuesday 4 April. The Bill will return to the Commons following the Easter Recess.

### **Science and Technology Committee**

On Tuesday 4 April, the Committee discusses the Industrial Strategy hearing from Nick Hurd MP, Minister of State for Climate Change and Industry, Department for Business, Energy and Industrial Strategy, from 10.30am.

### **Lords Motion**

On Wednesday 5 April Lord Stevenson of Balmacara (Labour) will move that the House of Lords regrets that the <u>Higher Education (Basic Amount)</u> (England) Regulations 2016 and the <u>Higher Education (Higher Amount)</u> (England) Regulations 2016 together with retrospectively changed loan conditions for existing students are further incremental burdens on students that risk worsening the opportunities for young people from low-income backgrounds, mature students and those undertaking part-time courses; and calls on Her Majesty's Government to report annually to Parliament on the impact on the economy of the increasing quantum of graduate debt, estimates of payback rates, and the estimate of the annual cost to the Exchequer of the present system.

A motion like this offers an opportunity for critical views to appear on Parliament's order paper, therefore an invitation to the House to put on record a particular point of view. The motion will be debated in the Commons following Recess.

# **Parliamentary Recess**

The Commons entered Recess on Friday 31 March and the Lords follow on Friday 7 April.

# **Great Repeal Bill White Paper**

On Wednesday 29 March the Prime Minister trigged Article 50, following this on Thursday morning the Brexit Secretary published the Great Repeal Bill White Paper.

The White Paper sets out the government's proposals for ensuring a functioning statute book once the UK has left the European Union. It provides the detail about:

- the repeal of the European Communities Act 1972
- how EU law will be converted into UK law
- how corrections will be made to the statute book, to ensure the law continues to function once we have left the EU

This morning it was also confirmed that a new Cabinet Committee has been established – the European Union Exit and Trade (Negotiations) Sub-Committee. Membership of the Committee is limited to the Prime Minister, the Chancellor, the Home Secretary, the Foreign Secretary and the Brexit Secretary.
